SUBSTRATE PREPARATION

Use **MCS1 Mould Clear Solution** to prepare the surfaces. Refer to the relevant data sheet for application guidance.

MIXING

Add 100ml of additive per 5L of paint.

Blend the Paint Additive for at least 1 minute or until fully dispersed.

APPLICATION

Apply decorative finishes in accordance with the manufacturer's instructions.

CONDITIONS & LIMITATIONS

Throughout application and drying time, ensure the room is well ventilated. Open windows and doors to allow a through draft.

DRYING

Follow the paint manufacturer's instructions.

CLEANING EQUIPMENT

Follow the paint manufacturer's instructions.
